INSTRUCTIONS ON COMPLETING THE SEDAR+ ELECTRONIC FILER AGREEMENT (EFA)

January 2023

LEGAL AGREEMENT INSTRUCTIONS

To be considered valid for SEDAR+ onboarding in advance of launch, all submitted legal agreements must be:

- signed by the authorized signatory or signatories (such as by having the signatory or signatories insert their signature image(s) or <u>using the Fill & Sign</u> tool to easily fill, sign, and send your forms or documents electronically);
- less than 8 MB in size; and,
- use the relevant file naming convention, outlined below.

The legal agreements **cannot** be:

- a PDF document that is a scan or images of printed page;
- a PDF document that is created by using the 'print to PDF' feature;

- S = subscriber number of self-filer or filing agent
- ISS = issuer number
- NRD = NRD number

Legal agreements cannot be signed with DocuSign during the streamlined pre-launch Onboarding process, which automates the extraction of data from the fillable PDFs. The data in DocuSign files is locked and cannot be extracted.

Similarly, PDF document cannot be created by using the 'print to PDF' feature.

The agreements must use one of the following:

- <u>Fill and sign functionality</u> that saves the agreement as a PDF
- Insertion of a signature image, then save the agreement as a PDF

- The Electronic Filer Agreement (EFA) grants an Electronic Filer (either a Filer or a Filing Agent) access to, and use of, SEDAR+ for the purpose of enabling and facilitating compliance with applicable securities legislation in Canada. Each Electronic Filer must complete and execute an EFA regardless of whether it intends to access and use SEDAR+ itself and/or through a Filing Agent. The EFA consists of three parts. Part A is a form to be populated with information pertaining to the Electronic Filer. Part B contains terms and conditions governing access to, and use of, SEDAR+. Part C is for acceptance and signing of the EFA.
- 2. Each Filer and each Filing Agent must complete and submit an EFA as part of its initial onboarding to SEDAR+:
 - (i) Filing Agents: A Filing Agent must complete and submit an EFA when first onboarding itself to SEDAR+.
 - (ii) Filers That Will Directly Access SEDAR+: A Filer that intends to access and use SEDAR+ directly on its own behalf (or directly on its own behalf, as well as through Filing Agent(s)) must complete and submit an EFA when first onboarding itself to SEDAR+.

- (iii) Filers Acting Only Through Filing Agent(s): A Filer that does not wish to access and use SEDAR+ directly itself, but rather engage a Filing Agent to use and make filings through SEDAR+ on its behalf, is still required to complete and submit an EFA. In these circumstances, a Filing Agent may be authorized (by completing and concurrently submitting a Filing Agent Authorization Form) to complete and submit an EFA on behalf of the Filer.
- 3. Only one EFA must be completed and executed for each Filer or Filing Agent. The Filer/ Filing Agent must make any subsequent updates to the information contained in Part A of the EFA (such as address, contact details, etc.) directly in SEDAR+.
- 4. The EFA may be completed in English or in French. In Québec, the Electronic Filer must comply with linguistic rights and obligations prescribed by Québec law.
- 5. Please read each Part of the EFA carefully.
- 6. There are no fees associated with the submission of an EFA.

PART A: ELECTRONIC FILER INFORMATION – GENERAL

Where the EFA is being completed by a Filing Agent on behalf of a Filer, then the information provided in Part A about the Electronic Filer should pertain to the Filer. Where the EFA is being completed by a Filing Agent on its own behalf (i.e., when first onboarding itself to SEDAR+), then the information provided about the Electronic Filer should pertain to the Filing Agent.

'Company' – A Company is an issuer other than an investment fund. This includes issuers regardless of their legal structure, including incorporated or unincorporated entities, trusts or partnerships.

'Third Party Filer' – A Third Party Filer is an individual or organization required or permitted to file a document because of an activity relating to or affecting an issuer or the issuer's security holders. A Third Party Filer is not required to have a company or investment fund profile in SEDAR+.

'Filing Agent' – A Filing Agent is a third party authorized to act on behalf of a Filer, including the transmission of electronic filings and the payment of associated fees on behalf of the Filer, through SEDAR+.
