## LEGAL AGREEMENT INSTRUCTIONS



To be considered valid for SEDAR+ onboarding in advance of launch, all submitted legal agreements must be:

- signed by the authorized signatory or signatories (such as by having the signatory or signatories insert their signature image(s) or <u>using the Fill & Sign</u> tool to easily fill, sign, and send your forms or documents electronically);
- less than 8 MB in size; and,
- use the relevant file naming convention, outlined below.

The legal agreements cannot be:

- a PDF document that is a scan or images of printed page;
- a PDF document that is created by using the 'print to PDF' feature;

ISS = issuer number

NRD = NRD number

Legal agreements cannot be signed with DocuSign during the streamlined pre-launch Onboarding process, which automates the extraction of data from the fillable PDFs. The data in DocuSign files is locked and cannot be extracted.

Similarly, PDF document cannot be created by using the 'print to PDF' feature.

The agreements must use one of the following:

- Fill and sign functionality that saves the agreement as a PDF
- Insertion of a signature image, then save the agreement as a PDF

## GENERAL INSTRUCTIONS



- I. If a Filer wishes to authorize a Filing Agent to complete an Electronic Filer Agreement (EFA) on behalf of the Filer, or to use and make filings on behalf of the Filer through SEDAR+, a Filing Agent Authorization Form (FAAF), that has been completed and duly executed by the Agent Authorizing Representative of the Filer, must be submitted.
- 2. The FAAF may be filed in English or in French. In Québec, the Agent Authorizing Representative of the Filer must comply with linguistic rights and obligations prescribed by Québec law.
- 3. You should read each section of the FAAF carefully.
- 4. Section 1: Provide the requested information about the Filer. The Filer may be an Individual or an Organization. An Organization is any entity that is not an individual.
- 5. Section 2: Provide the name of the Filer's Agent Authorizing Representative who is submitting the FAAF. If the FAAF is being submitted in connection with a Filing Agent's submission of an Electronic Filer Agreement (EFA) on behalf of the Filer, this Agent Authorizing Representative must be the same individual as the Filer's Authorized Representative identified in Section 4 of Part A of the EFA (and, for certainty, not a representative of the Filing Agent).

- 6. Section 3: Provide the requested information about the Filing Agent. The Filing Agent may be an Individual or an Organization. An Organization is any entity that is not an individual. Note that the Filing Agent must have already been onboarded to SEDAR+, i.e., they must have submitted an EFA on their own behalf to access and use SEDAR+.
- 7. Section 4: Select the areas of activity for which the Filing Agent is being authorized to use and make filings on behalf of the Filer through SEDAR+. This authorization will apply to any of the Filing Agent's users at the time a filing is made through SEDAR+. This authorization is non-exclusive, and the Filer may grant authorization to more than one Filing Agent at a time. ## MODIFICATION OR REVOCATION OF AUTHORIZATION



- 1. The Filer can use the **Filing Agent Authorization Form: Modification** or **Revocation of Authorization** to -
  - (i) **Option 1:** Modify (including to add or remove) the types of authorized activities for a Filing Agent that has been previously authorized to use and make filings on behalf of the Filer through SEDAR+; or
  - (ii) **Option 2:** Revoke the authorization for a Filing Agent that has been previously authorized to use and make filings on behalf of the Filer through SEDAR+
- The Filing Agent Authorization Form: Modification or Revocation of Authorization may be filed in English or in French. In Québec, the Agent Authorizing Representative of the Filer must comply with linguistic rights and obligations prescribed by Québec law.

This authorization will apply to any of the Filing Agent's users at the time a filing is made through SEDAR+. This authorization is non-exclusive, and the Filer may grant authorization to more than one Filing Agent at a time.
