Release 2.4.2 - NRD Enhancements

On Saturday, November 19, 2011, the following enhancements will be implemented on NRD in Release 2.4.2.

Chambre de la sécurité financière (CSF) membership fee collected via NRD's Annual Fee process

The contribution to the Chambre de la sécurité financière (CSF) will now be calculated & collected by NRD during the annual fee process. The CSF membership fee amount that will be charged for 2012 is \$257.47 (including taxes) for each current / active dealing representative of a Mutual Fund Dealer and/or Scholarship Plan Dealer registered in Quebec. (A single fee will be charged for individuals registered under both categories).

The firm's Annual Fee Summary will display the CSF membership fees showing the total amount paid by individuals registered as dealing representatives under Mutual Fund Dealer or Scholarship Plan Dealer categories, as applicable. If a dealing representative is registered under both categories the CSF membership fee amount will display under the Scholarship Plan Dealer category.
