



SEDAR+ Fee Calculation Errors Workaround

Known fee calculation errors in SEDAR+

As we transition to SEDAR+, there are some known instances where the system is not calculating fees accurately. There will be limited instances where the system is undercharging or overcharging fees, which are described in detail in the table below.

There are two known types of errors:

1. When a filing is made against a migrated filing or amends a filing that was originally filed outside SEDAR+. These errors are temporary and will eventually be eliminated as amendments stop being made against non-SEDAR+ initiated filings.
2. In certain rare circumstances, when a new filing is made on SEDAR+. There are fee calculation errors on certain infrequent filings that will continue until calculations are updated in a future release.

Work arounds to address known fee calculation errors

The following general work arounds are in place to address the known errors:

- When the system undercharges fees:
 - the recipient agencies will create an outstanding fee in SEDAR+ and contact the filer with instructions for payment. For information on how to search for and view an outstanding fee, click on 'Search filings with outstanding fees'.
- When the system overcharges fees:
 - A fee exception code can be obtained from the CSA Service Desk or the recipient agencies, as indicated in the table below, in advance of making the filing. That exception code is then entered at the time of filing so the system does not charge a fee for that filing. The recipient agencies will then create an outstanding fee in the system for the correct amount and contact the filer to pay the actual fee.
 - In certain circumstances, when the fee is calculated exclusively based on the fee attributes entered in the system, the filer can enter "0" (zero) in those attributes. No fee will be charged. The recipient agencies will then create an outstanding fee in the system for the correct amount and contact the filer to pay the outstanding fee.

Known fee calculation errors tables

The following two tables describe each known fee calculation error in SEDAR+, the jurisdictions where the error applies and the actions a filer should take to work around the error. It is possible that other fee calculation errors exist that have not been identified. These tables will be updated if new errors are identified or as errors are resolved.

FAQs

Why are there fee calculation errors in SEDAR+?

Most fees calculate correctly in SEDAR+ but there are a few fee calculations errors that exist for two main reasons: (1) there isn't sufficient data in the migrated record to calculate the fee or (2) there are system bugs that could not be resolved before go-live. The fee calculation bugs generally relate to infrequent filings.

What is a fee exception code and how does it work?

A fee exception code is a one-time use code that is entered at the time of filing and allows the filer to submit a filing without paying a system fee or regulatory fee in a particular jurisdiction. If a regulatory fee is owed in multiple jurisdictions, a code will be required for each jurisdiction. The fee exception code(s) is(are) obtained from the CSA Service Desk or the respective recipient agency, as indicated in the table above. A fee exception code is granted upon request if the fee is calculated incorrectly by the system, or a fee is not owed by the filer for the filing that is being made. When a fee is owed but a fee exception code is used to avoid a fee calculation error, the filer will need to return to the system and pay the correct outstanding fee after it has been created by the recipient agency.

When should I contact the CSA Service Desk for fee exception codes and what process should I follow?

You should contact the CSA Service desk for fee exception codes if you require fee exception codes from multiple jurisdictions for the same filing. The CSA Service Desk will send you fee exception codes for all applicable jurisdictions in a single email. To obtain the fee exception codes send an email to the CSA Service Desk and include:

- the following information in the subject line of the email: **Subject: Request for SEDAR+ fee exception code - <Enter impacted filing type> OR <Enter Fee Error ID>** (as provided in the tables above).
- the following information in the body of the email: Issuer name, profile number, filing number, filer contact name and email address, the list of jurisdictions for which a fee exception code is required, and the Fee Error ID in the table above (or the reason for the fee exception code if the Fee Error ID is not known).
- If the request is approved, the CSA Service Desk will send you a reply that includes fee exception codes for each requested jurisdiction.

When should I contact the recipient agency for a fee exception code and what process should I follow?

You should contact the recipient agency for a fee exception code if you require a fee exception code only from a single jurisdiction. To obtain the fee exception codes send an email to the recipient agency and include:

- the following information in the subject line of the email: **Subject: Request for SEDAR+ fee exception code - <Enter impacted filing type> OR <Enter Fee Error ID>** (as provided in the table above).
- the following information in the body of the email: Issuer name, profile number, filing number, filer contact name and email address, the list of jurisdictions for which a fee exception code is required, and the Fee Error ID in the table above (or the reason for the fee exception code if the Fee Error ID is not known).

Before submitting a filing, SEDAR+ provides a 'Fee attributes' page where you will enter the code.

- Enter a fee exception code for each jurisdiction where the fee calculation error applies. Select 'Add code' to add more exception codes to a filing. System fee exceptions will have their own code.
- Click save and move to the Fee summary and payment page. You will see that the Amount is '\$0.00' in the fee breakdown against the jurisdictions that have a code entered for them.
